Internet Privacy Policy**

Las Vegas Dissemination Company (“LVDC”), parent company to Acctg.LVDC.com, is located at 8924 Spanish Ridge Avenue, Las Vegas, Nevada 89148. I. APPLICATION OF THIS PRIVACY POLICY

This Privacy Policy applies to all websites owned or operated by LVDC (www.lvdc.com) including Accounting.LVDC.com. LVDC websites may be accessed through domain names in addition to the domain name listed above. This Privacy Policy does not apply to information collected by LVDC by means other than through the LVDC websites.

Certain services offered through LVDC websites may be processed or provided by other entities under contract with LVDC even though it appears that you may not have left the LVDC website. This Privacy Policy does not apply to information collected by other entities except that LVDC will treat information it receives about you from other entities under the terms of this Privacy Policy. To determine the Privacy Policy applicable to information collected by these other entities please consult the websites of the other entities.

II. INFORMATION WE COLLECT ABOUT YOU

GENERAL INFORMATION

When you use the Internet, your web browser or client software may transmit certain information to the server that host the websites you visit. The information may include the unique number assigned to your service or Internet connection, the capabilities and features of your computer, your geographic location, your movement within and interaction with the website, including what pages you look at and what information you download. When you visit LVDC websites, the LVDC servers collect such information. LVDC uses this information to generate aggregate statistics about visitors to its websites.

PERSONALLY IDENTIFYING INFORMATION

LVDC only collects personal information that you voluntarily provide to us or voluntarily provide to other entities who share that information with us. “Personal Information” is information through which you can be identified. The Personal Information that LVDC collects through its websites or obtains from the other entities depends on the nature of your online activity. Personal information that LVDC may collect from you directly or through other entities, includes your name, address, e-mail address, telephone number(s), fax number, birth date, gender and other information that you voluntarily provide. The personal information is collected by e-mail, through online forms, and through your activities on the LVDC websites.

III. HOW WE USE THE INFORMATION WE COLLECT

LVDC may use the information collected by us or other entities for; (1)marketing purposes, including but not limited to, notifying you of special product offers and information; (2) to enable us to contact you

for customer service needs after you sign-up for certain products; (3) to respond to inquiries, complaints and other communications; (4) to cross-reference with other personal information that we have acquired about you or may acquire about you through other sources; and (5) for profiling or demographic purposes.

IV. DISCLOSURE OF INFORMATION WE COLLECT

Except as provided below, LVDC will not sell, trade, or disclose to third parties any personal information obtained through its websites or obtained from other entities, without your consent. LVDC may disclose personal information; (1) to comply with a court order, subpoena, search warrant or other legal process; (2) to comply with legal, regulatory or administrative requirements of any governmental authorities, (3) to protect and defend LVDC, their affiliates, and all of their officers, directors, employees, attorneys, agents, contractors and partners, in connection with any legal action, claim or dispute; (4) to enforce the Terms of Use of LVDC websites and its affiliates; (5) to prevent imminent physical harm; (6) to businesses that LVDC may use for purposes of performing functions on behalf of LVDC; and (7) in connection with the sale, assignment, or transfer of any LVDC website.

V. CHOICE REGARDING PROVIDING INFORMATION

General information is collected whenever you browse the LVDC website. The LVDC website does not provide any means for opting out of providing general information when you browse its websites. An example of general information would be noting the domain name of the website from which you linked to our site or advertisement.

You can browse the LVDC website without providing any personal information. However, providing personal information is required to use services offered through the website.

VI. CHANGING PERSONAL INFORMATION OR OPTING OUT

You can opt out of receiving certain communications. Opt out options will be indicated when they are available. If you believe that any information collected by LVDC about you is not correct or has been changed, please send an e-mail message to info@LVDC.com explaining the correction or change and provide any relevant confirmation or reference number.

VII. ACCESS

The general or personal information collected through the LVDC website or provided by other entities is not currently accessible to you, except that confirmation is provided for some services.

VIII. SECURITY

General information and personal information collected by LVDC websites is stored on secure servers. The secure servers are protected by firewalls and other standard security procedures. The secure servers are not generally accessible by unauthorized third parties, but could become accessible in the event of a security breach. Third party Internet sites and services accessible through LVDC websites have separate privacy and data collection practices, independent of us. LVDC has no responsibility or liability for these independent policies and actions. You are solely responsible for maintaining the secrecy of your passwords or any account information. Please be careful and responsible whenever you are online.

If you post personal information that is accessible to the public, you may receive unsolicited messages from other parties in return. While we strive to protect your personal information, LVDC cannot ensure or warrant the security of any information you transmit to us, and you do so at your own risk.
